

**SKIERS PIER, INC. STORAGE RENTAL CONTRACT**

I hereby authorize Skiers Pier to store my boat, and agree to pay Skiers Pier in accordance with the terms and conditions of this contract and hereby accept them.

The granting of any storage space or hauling service or of any other service is accepted with full understanding and agreement that the yard, its officers, employees or agents shall be responsible for the safety of any boat; and none shall be liable for any loss or damage from any cause, including fire and theft.

Owner agrees that neither he/she, nor his/her family, guests, agents, or invitees will use yard equipment.

Owner agrees that any granting of space and/or service is purely a rental for a specific term and there is no guarantee of anything beyond that term.

Owner agrees that any and all loss or damage to the boat, its equipment, and all property of the owner shall be borne by the owner.

Owner agrees to maintain insurance coverage for liability and property damage of his/her vessel.

Due to fire hazard, absolutely no work of any kind may be performed by boat owners within the storage building or on the storage lot. Access to storage buildings will be restricted to Skiers Pier personnel.

- o \$250 (Outside storage)
- o \$200 (PWC Indoor)
- o \$100 (PWC Outdoor)

**ALL PAYMENTS ARE DUE BEFORE BOAT IS PUT INTO STORAGE!**

If litigation by Skiers Pier is necessary to collect any amount or amounts due under this agreement all costs of collection including but not limited to attorney fees, sheriff's fees, interest costs and the like, will be added to this account and are due and payable to Skiers Pier.
